Tickets for your customers

Tickets for your customers can be purchased at a special price of CHF 19.00 incl. VAT. You will receive the tickets as a print@home ticket by e-mail. You can print them out or send them digitally.

A purchase of 10 tickets is compulsory.

Delivery and removal incl. forwarding agent

Deliveries must show the name of the exhibitor, the stand number and the hall. The delivery address is FitnessEXPO c/o Hall 622, Hardstrasse 219, 8005 Zurich. The instructions of our logistics team, the security service and the police must be observed. Traffic and law violations must be paid by the exhibitor (e.g. parking fines). Deliveries and removal must be registered no later than 1 month before the start of the fair.

Customs

Shipments from abroad must be cleared through customs by the exhibitor. The exhibitor must bear the costs incurred.

Entry during the fair

Access to the exhibition grounds during the fair is possible in the morning from 08.00-09.30 hrs. All vehicles must leave the grounds by 09.30 hrs at the latest.

Stand fees and additional costs

The tariffs according to the registration documents and the conditions of participation apply. Only the exhibition space is charged with the stand fee. Additional costs such as electricity, carpet, internet, parking tickets and the obligatory ticketing etc. will be charged separately according to the price list.

Payment deadlines

Unless otherwise stated on the invoice, a payment period of 10 days shall apply.

Swiss VAT

All prices are exclusive of VAT. (except ticket prices). VAT is payable in addition in accordance with the current VAT rate. As the service is provided in Switzerland, VAT must also be paid by exhibitors from abroad.

Internet

Internet connections are possible inside the hall. Order with the registration (see also attachment).

Power connections

The connection price includes the ordered plug without distribution. The power consumption is included. Fine wiring on the stand area must be provided by the exhibitor. Sketch with the exact connection position to welcome@fitnessexpo.ch by 1 April 2022 at the latest.

Rental furniture

Send enquiries for rental furniture to welcome@fitnessexpo.ch. Deadline for orders is 1 April 2022.

Forklift driver

During set-up and dismantling times, a forklift including driver is on call on site. The driver can be requested at the checkpoint. Costs per hour CHF 90.00. The assignment will be reported and invoiced after the exhibition. A responsible person from the exhibitor must supervise loading and unloading. Any liability is rejected.

Empties storage area

There is a limited area available for empties. Storage cannot be guaranteed.

Stand cleaning

Stand cleaning is the responsibility of the exhibitor.

Waste disposal

Each exhibitor, stand constructor, supplier, etc. is responsible for waste disposal. A press container is available for small quantities of waste. A separate container is available for paper and cardboard. If containers or similar are required on the exhibition grounds, they can be ordered from the exhibition management at a charge.

Security

The exhibition halls are guarded by a security company. We recommend removing valuables from the stand and locking the stand. The organiser accepts no liability for theft or damage to property.

Ambulance

A medical service will be on site during the fair.

Fire and escape routes

Open fires are prohibited on the entire premises. Escape routes must be kept clear at all times

Parking spaces Exhibitors

There are no parking spaces available on the exhibition grounds. Parking tickets can be obtained for the Jungholz multi-storey car park. Entry height 2.20 m. A solution for parking vans and trucks will be presented shortly before the fair, the parking tickets can already be purchased.

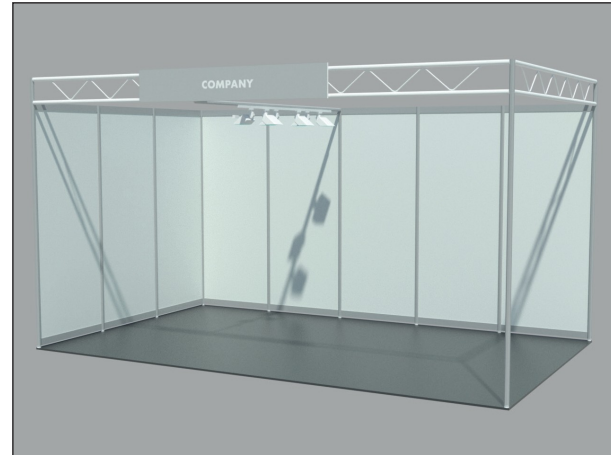





Use in conformity with the law and the contract

Force majeure

By registering for FitnessEXPO, these conditions are automatically accepted.

General provisions

- This registration is binding for the exhibitor.
- The stand space must be paid for in full up to 8 weeks before the fair.
- The stand space is booked with the signing of the contract.
- If an exhibitor renounces his participation after signing the contract, for whatever reason, 50% of the space is to be paid. 4 weeks before the start of the fair, 100% of the space is to be paid for.
- The exhibitor is responsible for ensuring that his stand is set up and dismantled on time. If the deadlines are not met, any additional costs will be charged in full to the exhibitor.
- Installations and performances of any kind that obviously disturb neighbouring stands or visitors are not permitted.
- Advertising and canvassing are only permitted within the boundaries of the exhibitor's own stand.
- The FitnessEXPO will be guarded by a security company outside the opening hours. The organiser assumes no duty of care for exhibition goods, stand equipment or other items brought to the event and excludes all liability for damage and loss.
- Insurance is the responsibility of the exhibitor.
- Prior to the opening of FitnessEXPO, the public areas excl. stand areas will be cleaned by FitnessEXPO.
- Each exhibitor is responsible for waste disposal. Waste containers and containers subject to a charge must be ordered 10 days before the Expo.
- The legal provisions on the protection of intellectual property rights, in particular patent, trademark and design rights, must be respected. Anyone who infringes rights may be held liable under civil and criminal law.
- Anyone playing music from sound carriers on the premises and in the halls shall be obliged to obtain a licence from SUISA.
- FitnessEXPO is entitled to use pictures of all exhibitor stands for advertising purposes.
- Stand personnel will only be admitted with FitnessEXPO passes. Each exhibitor receives 5 exhibitor passes per stand. Additional passes can be ordered until 01. July 2023 from welcome@fitnessexpo.ch. CHF 20 excl. VAT will be charged for each additional pass.
- FitnessEXPO excludes all liability and recourse in the event of damage, loss or confiscation, including during delivery and removal.
- The place of jurisdiction is Zofingen AG.
- The selection of the Marketing Package Basic is obligatory for exhibitors.
- Material deliveries: Please note that neither FitnessEXPO nor the location accept deliveries of goods. If you are expecting such, you must be on site. Give your mobile phone number to the chauffeur.
- Reusable tableware: Small samples in disposable units are allowed. Please ensure that the dispensed units (cups) have a maximum capacity of 6cl.
- Vehicles in the hall: The fuel tank must be empty and the battery must be disconnected. Furthermore, access to the vehicle key must be guaranteed at all times so that the vehicle can be moved if necessary.
